TOP 100 COMPANIES

he third year of Kirklees
Top 100 Companies offers
a welcome return to inperson gatherings, and we
are delighted to have the
opportunity to meet up with our
top companies and enable them to
forge new links on topics of shared
interest.

Congratulations to the Top 100 who have survived the pandemic and adapted their businesses to offer innovative products and services, increasingly online and many directly contributing to the demand for better health and wellbeing in a more sustainable world.

The historic sectors of the Kirklees economy in textiles and precision engineering remain strong at the heart of the list, and we are seeing innovation across these industries as well as newer technologies and business models.

There are 26 new entries in this year's list and 5 new entries in the Top Ten, with the battle for the top place being tightly fought between our biggest hitters.

The list has been produced by Huddersfield Business School using published accounts data from the FAME BVD database, on five criteria related to financial performance, as explained by Professor Jill Johnes in the methodology article overleaf.

New features include an updated Innovation Spotlight to tie in with the West Yorkshire Innovation Festival, plus insights from the region's HR directors who meet to share best practice in talent retention, hybrid working, apprenticeships and graduate development.

Please note: inclusion in the Kirklees Top 100 Companies listing is based on objective criteria using company accounts published in the FAME database prior to July 2022 and does not imply the endorsement of the partner organisations listed above.

How the list was compiled

Background

he Kirklees Top 100 was compiled using as its source the FAME BVD database that contains a variety of information on more than 11 million companies in the UK and Ireland.

The information in the database includes financial data, information on directors and company structure including shareholders, subsidiaries and branches, and industry descriptions and SIC codes; much of the information derives from accounts and documents filed at Companies House (in the UK). The FAME BVD database is the only source used for the listing.

Strict parameters were used to derive the set of companies from which the Top 100 were ultimately drawn. The first parameter concerned the geographical location of companies in the Kirklees Top 100. The boundary was determined strictly by Kirklees postcode. Thus, we selected from the FAME BVD database all active companies with a registered office address within the Kirklees region defined as having a Kirklees postcode. Huddersfield Business School researchers downloaded the relevant data on July 1st 2022 and any data available in the FAME BVD database after this date was not included in this particular edition of the Top 100 list.



METHODOLOGY

he Kirklees Top 100 uses the methodological approach of the York Top 100. The ranking is derived from the following indicators: staff head count (i.e. number of employees); turnover; growth in turnover between the latest and previous years; profit before tax; and shareholders' funds. Each of these indicators is ranked (best- to lowest-performing), and then these rankings are summed. The final position is determined by ranking the sum of ranks. In effect, each measure carries

equal weight in determining the

final ranking from the underlying

metrics

The period over which the ranking applies is determined by the latest information held in FAME BVD and filed by each company in the Kirklees list. Any subsidiaries of larger companies included in the list were removed allowing us to focus on ultimate ownership, so long (of course) as the registered office was in the defined Kirklees area. Companies with turnover less than £1000 or with non-numeric data were removed from the data set. No businesses were offered the option of being included (or not).

ECONOMIC CONTEXT

ompanies have faced various challenges over the past two to three years particularly with the Covid-19 pandemic and with the aftermath of Brexit.

In terms of this list, it should be remembered that each company's data is at a specific snapshot (indicated by the date in the "Latest Account Date" column) and so the extent of the impact of specific external factors will vary by company. One company's data is pre-pandemic, 37% relate to 2020, 62% relate to 2021. We can see that 4 companies whose data was published at the end of December 2021 are in the Top 10. Further scrutiny

of the Top 10 provides little pattern in terms of types of companies which are particularly thriving in Kirklees. We can see companies that we might expect to have done well in a Covid period such as providers of online shopping, computers and health-related products; these sit alongside an array of business areas such as financial services, brand consultancy, paint production, textile flooring specialists, recovery services, and civil engineering - and these are just in the Top 10! It appears that Kirklees has a vibrant and diverse business economy with a wide range of services and manufacturers.

Limitations

his list does not claim to indicate each business's economic importance to the Kirklees geographical area.

It is based on five specific metrics which are deemed to be indicators of success. All metrics contribute equally to the final ranking. The list can therefore be seen as a means of showcasing and celebrating business activity in the Kirklees region. Unfortunately, not all companies' complete set of data are included in FAME BVD, and so businesses which might expect to be in the list are not for that reason.

Kirklees also hosts important businesses which do not have a registered primary office in the region. These businesses, along with major public sector organisations, are showcased separately in this publication and are not in any ranked order.

The Importance of Talent Development

LEARN MORE ABOUT THE SCHEMES THAT KIRKLEES COMPANIES HAVE ON OFFER FOR TALENT DEVELOPMENT AND HOW BUSINESSES CAN TAP INTO TALENT FROM THE UNIVERSITY OF HUDDERSFIELD.

he recent pandemic has no doubt impacted what people search for in a job. Whether it's flexible/hybrid working or a competitive salary, candidates are now more attracted to roles that help them climb the career ladder but also support their mental wellbeing and provide the right work/life balance.

Markets have also become more competitive. Businesses are having to find ways to stand out and be more attractive to potential candidates but also motivate and retain their current workforce. Many companies like logistics specialists, Hoyer, have had to adapt how they recruit, as Hoyer's HR Advisor, Sarah Wheatcroft, explains, "For our driver roles we are having to work hard to remain attractive in the workplace. At the height of the driver shortage, HGV market salaries rose significantly, and so we also applied significant salary incurrences to ensure our salaries remained in the 'upper decile'

"Drivers are also more concerned now with their shift patterns and so we are having to respond to offer more favourable working arrangements to retain."

BRINGING TOGETHER KIRKLEES' HR EXPERTISE

A talent group consisting of HR specialists from businesses within the Kirklees Top 100 Companies formed two years ago to discuss the challenges and opportunities when it comes to recruitment, from hybrid working to apprenticeships and graduate development. The group sessions enable HR practitioners to share best practice, as well as offer peer-topeer support. Numerous sessions covered what companies across the region have in place for talent development, from apprenticeships to graduate programmes. Cummins has a global Apprentice programme that enables young people to gain industry experience working alongside highly experienced technicians in the field, whilst gaining a qualification. In 2021, UK Greetings reshaped its training and upskilling programme to help develop its current workforce and strengthen its recruitment of apprentices that range from school leavers, graduates, to those wanting a

career change. It also introduced a leadership apprenticeship scheme to upskill its current employees. Buy It Direct has a 24-week graduate programme designed to fit round busy roles that uses a blended learning approach, with face-to-face, e-learning and virtual sessions. The aim of the scheme is to discover strong talent and set graduates up to develop and grow within the business.

There are many other companies from a whole range of sectors across the region that have schemes and programmes in place and are finding innovative ways to attract and retain talent, all of which are helping to put Kirklees on the map as an exciting and dynamic place to work.



GRADUATE RECRUITMENT

laire Aydoğan, the University of Huddersfield's Head of Careers and Employability, explains the opportunities available through the University for businesses looking to attract the right talent.

"We provide numerous routes into industry for our graduates to gain valuable work-based learning and relevant work experience that equally benefit the businesses, from internships to placements. "Placement years usually take

place in the third year and involve 12 months in industry, enabling the student to gain valuable insight and experience.

"The Santander Internship Scheme provides funding exclusively for local SMEs and recent graduates. Interns usually work 35 hours a week for 8 weeks, and in many cases, subsequently secure permanent roles.

"We're finding that our 96% of our graduates are finding jobs within 6 months of graduating."

Laura Forester-Green, the


University of Huddersfield's KTP Manager, adds, "The University of Huddersfield also delivers Knowledge Transfer Partnerships (KTP) that are partly funded research collaboration projects with a University designed to develop innovative solutions and help business growth.
"A KTP Associate, usually a graduate, will come and work within the business for 12 - 36 months, depending on the length of the

project and often end up working

Spectrum Yarns Ltd

his Slaithwaite company owns one of the most well-known trade names in the golf clothing world ... Glenbrae.

People into crafts will also be familiar with its other main trade name, Stylecraft, and these top brands are produced by the 115-strong workforce at the Spectrum Yarns mill on New Street in the heart of the village. Glenbrae (www.glenbrae.com) is sold in more than 90 of the UK's top 100 golf clubs and its top quality range. mainly tops and waterproofs, is made from lambswool or merino wool. Stylecraft does a huge range of yarns for people who love to knit and crochet and has its own website too at www.stylecraft-yarns.co.uk but also sells in 900 retail outlets nationwide. The company also makes yarns for



other businesses around the world. Managing director Richard Brown, 68, said: "People overseas want to buy products with Made In The UK on them and it's the better quality they want. We only make top quality yarns."

The company has just invested £1.7m in new machinery and will be investing another £3.5m soon in more state-of-the-art technology to ensure it's self-sufficient in its yarn-making and not reliant on imported raw materials.

Richard began the forerunner to Spectrum Yarns back in 1973 when he was a 19-year-old mechanical engineering student at Imperial College in London. He set up a textile machinery company and over time that involved into spinning yarn and the Spectrum Yarns name appeared in the mid-1980s.

The company has certainly pushed the boundaries in terms of performance fabrics, making fabrics for fighter jets and fireproof safety clothing. It's a true family business as Richard's daughter, Danielle, is the operations director and will take over

He added: "Despite the success of our own brands we will keep on

when Richard retires.



manufacturing yarns for others as it means we must keep up-to-date with the latest skills and knowledge within the industry. That's great for our mental agility and the business. "Glenbrae and Stylecraft have become trusted trade names with great reputations and we are so proud they come from here in the Colne Valley."

HIGHEST NEW ENTRANT







Interior Goods Direct Ltd

his company is one of the UK's leading online suppliers of any furnishings to do with windows and everything is manufactured at its premises in Grange Moor.

It has become the highest new entrant in the top 100 companies in Kirklees after having a phenomenal 12 months in 2021.

Interior Goods Direct's profit after tax in 2020 was just over £2.1m but that had grown threefold to £6.6m by the end of May 2021.

The company's products include ready-made and made-to-measure

curtains, curtain poles and every kind of blind you could imagine including roller, vertical, Roman, pleated and wooden along with plantation shutters.

The company has been selling exclusively online since 2003 and has grown from just a handful of people Its 40,000 sq ft factory has production spread over three floors and all products are manufactured by small and highly skilled teams to meet exacting standards.

It lets potential customers have up to eight free samples so they can be sure the colours are just what they want before they buy. As just about everything is manufactured in-house it means Interior Goods Direct can sell its wide range of products at industry-leading

prices.

The company website states: "We aim to bring the widest range of products available without compromising on quality. Therefore, we only work with suppliers with the best reputations and finest products."



HIGHEST PLACED SME



Phoenox Textiles

hoenox Textiles are the UK's leading manufacturer of rugs and mats for the home and has a phenomenal record when it comes to caring for the environment.

This family firm in Scissett has a zero

to landfill policy and does everything it possibly can to reduce its carbon footprint and recycle other products that people often throwaway. For instance, it uses more than 7.5 million plastic bottles every year to

create the extra tough membrane that bonds the tufts to the backing on all its mats and uses almost 6 million recycled cotton garments for the tufting on the cotton mats.

More than 100 tonnes of recycled plastic goes into the rubber-backed products manufactured by Phoenox.

plastic goes into the rubber-backed products manufactured by Phoenox. Its packaging is either cardboard or recyclable, biodegradable plastic and products for main customers go out in large green containers which are then sent back to be reused.

Its manufacturing is powered by green energy such as hydro pumps, wind turbines and solar.

The brand portfolio now includes Hug Rug, My Mat, Howler & Scratch pet mat range, Dip & Drip bathroom mats, Buddy stain resistant rugs and the Phoenox Rug Collection which it sells through its www.hugathome. co.uk and its www.rugguru.co.uk websites. The company also works with top retailers to provide their own in-house brands.

In recent years Phoenox has invested in new machinery so it can produce new product ranges and a wider variety of designs.

The company also makes other products such as throws, cushions, aprons, tea towels, oven gloves and hob covers.

Phoenox Textiles was established in 1954 with 10 staff by Jack Mosley, a local weaver who began by making fabric for bus seats and traditional hearth rugs that were woven from locally sourced wool and acrylic along with cotton from Lancashire. It is now run by the third generation of the Mosley family and employs more than 200 people at its two sites in Scissett. Many of its workforce comes from the surrounding rural

Growth through innovation

opportunities are available for businesses in the region looking to innovate, from funding and grants to research collaborations with the University of Huddersfield.

ith initiatives such as the West Yorkshire Innovation Network (WYIN), it's clear that driving innovation across the region is high up on the agenda. Launched by West Yorkshire Mayor Tracy Brabin and her innovation team at the West Yorkshire Combined Authority (WYCA), its aim is to create an ecosystem of innovation support for businesses across the region, of which the 3M BIC is proud to be an anchor member.

As the Innovation Spotlight demonstrates, companies across Kirklees are excelling in innovation, driving change across their industries, from non-destructive testing and manufacturing to healthcare. You'll also notice that many of them are linked to the University of Huddersfield, collaborating on research projects or taking advantage of opportunities to recruit young talent.

There are plenty of funding and support solutions to get your vision off the ground, from national initiatives to local funding. Here are a few to get you started.

Local support

Local SMEs can access Kirklees Innovation Vouchers, a scheme developed by Kirklees Council. With grants of up to £5,000 available. businesses can utilise them to develop innovative products, solutions or services. Grants such as these are perfect to get ideas off the ground that might be in the early stages of development. The vouchers can be used to part-fund product design or prototyping projects at the 3M BIC. In addition, the University of Huddersfield may contribute to the cost of introducing an academic to work with a company to help develop





longer-term collaborative research projects.

Regional support

Connecting Innovation, which runs until June 2023, provides a dedicated and specialist SME innovation support and brokerage service, run through WYCA. SMEs within the Leeds City Region can get up to 12 hours of support (or more if required) plus access to a dedicated Innovation Growth Manager that helps access funding and grants, connect with specialist expertise and organisations, as well as supports project implementation.

The Kickstart Innovation Fund, which is part of Connecting Innovation, also offers grants of up to £24,999 for innovation-led projects delivered by B2B SMEs.

Based at the 3M BIC, the Leeds City Region Supply Chain Programme provides a wide variety of support to SMEs and associated services in the manufacturing sector. Delivered by the University of Huddersfield and funded by the ERDF until March 2023, businesses can benefit from expert advice from its experienced field team and get access to grants and specialist expertise.

National support

Initiatives like Innovate UK EDGE provide expert innovation support for investor networks, IP expertise and international partnerships to help support innovation and growth. Grants between £25k and £10m (all company sizes) and innovation loans between £100k and £1m (UK SMEs) can be accessed via Innovate UK. Opportunities may fit within one of the Industrial Strategy's grand

challenge areas, including Artificial intelligence (AI), data, ageing society, clean growth and the future of mobility, however, other types of innovation or technology projects are also considered

A Knowledge Transfer Partnership (KTP) is a government-funded programme through Innovate UK, delivered by universities across the UK, including the University of Huddersfield. KTPs partner a business with a university and a KTP associate, usually a post-graduate, to work on a specific project that will help solve strategic challenges within the business and help support growth. KTPs can help increase competitive advantage, improve performance and increase profitability. They can also help embed new knowledge and positive cultural change within an organisation, as well as support succession planning. Local companies such as Paxman Scalp Cooling and AUS have taken advantage of KTPs to structure their R&D programmes. The possibilities for innovation are endless, so don't let budget and time hold you back. If you're unsure where to start, the teams at the 3M BIC, University of Huddersfield or Business Kirklees will be more than happy to help.

BUSINESS PROFILE

1. BUY IT DIRECT GROUP

his is an inspirational company that has undergone phenomenal growth in just 23 years with its profits recently almost quadrupling in just one year.

Buy It Direct, which employs more than 1,250 people and has 2 million sq ft of warehouse space, posted profits of £26.5m in 2021 compared to just over £7m in 2020. Turnover had gone up to almost £437m compared to almost £295m in 2020. Yet it all began with a £2,000 loan and founder Nick Glynne's desire to set up his own business in 1999. The business has grown from a computer shop to one of the biggest names on the internet because Nick has always had the vision to fully embrace the immense selling power of online retailing. Anyone browsing for everything from laptops to fridges to showers to sofas to hot tubs will be familiar with Buy It Direct based on Leeds Road in Huddersfield ... but this is a company that never stands still, branching out and acquiring other businesses along the way. Buy It Direct now incorporates several other brands including Appliances Direct, Laptops Direct, Furniture 123, Better Bathrooms and Outdoor Living. Nick, who was named Business

Huddersfield Examiner Business Awards in 2016, founded his businesses on two mottos -"anything is possible" and "detail is everything."

The story started when Nick started Easy Computers in Fartown, Huddersfield, and within a couple of years it had become one of the first businesses to sell laptops online by launching the website acernotebooks.co.uk. The business saw phenomenal growth and by 2004 laptopsdirect.co.uk was set up so the business could sell a far wider range of laptops.

By 2006 two more brands were up and running - Direct TVs and Aircon Direct - and a year later the company moved into a new HQ in Huddersfield.

In 2008 the new AppliancesDirect. co.uk brand greatly expanded the product range with the company also moving into furniture with the acquisition of Furniture123 in 2012. Nick's quick to spot emerging markets so acquired drone dealer Proflight-UK in 2015 and rebranded it (yes, you've guessed it) to Drones Direct

A 150,000 sq ft warehouse opened in Elland in 2017 soon followed by a new home delivery depot in Luton to serve the south of England. In 2019 Nick acquired the UK's largest bathroom retailer out of administration, Better Bathrooms,

which has led to even further expansion. In 2021 the company acquired a lease on a gigantic 525,000 sq ft. distribution centre near Castle Donington in Leicestershire.

Nick has a great sense of social responsibility with Buy It Direct donating £35,000 to organisations combatting the spread of COVID-19 during the first lockdown in 2020. In 2018 Buy It Direct donated new computers and servers to the Rwanda Charity Eye Hospital which has helped thousands of people suffering from ailments like cataracts and glaucoma. Recycling is given a top priority - so much so that the company invested in a state-of-the-art recycling start-up called AREERA. The company uses robots to separate out the components of TVs and monitors so that everything can be recycled. It is now the largest screen recycler in the country. employing over 100 people from its site in Elland, West Yorkshire. Repair and refurbishment are also important to this environmentallyconscious company. Buy It Direct bought another business out of administration called Trojan Electronics. Based in Swansea, the business employs 150 people to repair, refurbish and resell home electrical items.

2. THORNTON & ROSS

his Huddersfield pharmaceutical company is 200 years old this year and makes some of the UK's biggest and most well-known brand names.

Thornton & Ross' impressive list of household trade names includes the UK's leading disinfectant Zoflora along with cough medicine Covonia, Cetraben cream for dry, sensitive or eczema-prone skin and Hedrin which gets rid of head lice.

It also provides many prescription products such as moisturisers and innovative medicines aimed

at the treatment and prevention of common bone disorders such as osteoporosis and Vitamin D deficiency, along with a wide range of generic and speciality products. Many are supplied to the NHS. The company's manufacturing base is on Manchester Road in Linthwaite, it now employs more than 700 people and earlier this vear relocated its 150 office and commercial staff to the historic Globe Mill in Slaithwaite, occupying the full third floor of this iconic building which dates back to 1887. During the Covid-19 crisis Thornton & Ross donated more than 100,000 skincare moisturisers to frontline NHS staff to minimise the discomfort of irritated skin along with sore and cracked hands caused by prolonged use of face masks, frequent hand washing and increased hand sanitising. It also donated 14.000 bottles of Zoflora to NHS workers in Huddersfield. Other consumer products made by Thornton & Ross that you'll be familiar with include Eurax for itchy skin problems, Flixitol moisturising foot cream, cold sore cream Virasorb, children's cough mixture Tixylix, Savlon antiseptic cream, Radian B for muscular aches and pains, Mycota which treats athlete's foot, Acriflex antiseptic burns cream, Metanium which both prevents and soothes nappy rash

and Eucryl tooth powder to polish your teeth.

Children's healthcare is a large part of the business and its Care range has 80 products ranging from olive oil eardrops through to gels to soothe chickenpox. Many are classic medicine cabinet essentials for minor ailments. People can buy its products direct online from the company through part of its website called Thornton & Ross Direct. It also does great charity work, setting up a special fund to help groups tackling knife crime in the Kirklees area after one of its staff. 53-year-old Robert Wilson, was murdered by two teenagers in an unprovoked attack.

Thornton & Ross was founded as a manufacturing chemist for pharmacists by Nathan Thornton and Phillip Ross in an old dye house on Colne Vale Road, Milnsbridge, on November 23, 1922. Mr Thornton had previously worked with coal tar based disinfectants and his interest lead him to develop the company's first brand, Zoflora.

Thornton and Ross became part of the STADA group in 2013. STADA Arzneimittel AG is a German Stock Corporation with headquarters in Bad Vilbel, Germany, and sells its products in 120 countries. These are both specialty pharmaceuticals and non-prescription consumer health products.

3. PPG ARCHITECTURAL COATINGS

he PPG plant in north Kirklees is Europe's largest paint manufacturing complex.

PPG, which makes paint brands Johnstone's and Leyland, is based at a 65-acre site in Birstall where it has been since 1983. It employs more than 1,500 people across the UK and Ireland.

It's part of a global company manufacturing any kind of paint you can think of from car paint – two out of three cars made in Europe and North America use PPG paint technology – to industrial paint including coatings for drinks cans and paint for homes for the inside, outside, wood and metal. If anything can be painted, PPG has the product.

Yet it didn't even start out as a paint company. It was founded in 1883 as Pittsburgh Plate Glass but retained the PPG moniker even though it diversified to become a paint manufacturer and supplier. It has 47,000 employees worldwide, operates in 70 countries, has 156

manufacturing centres and total vearly sales are around \$14 billion. PPG also has a very strong social conscience and one of its main community schemes is its Colorful Communities programme which encourages its staff to volunteer their time and PPG products to brighten up their neighbourhoods. It was set up in 2015 to invest \$10m in 10 years and so far 386 projects have been completed in 42 countries, enhancing the lives of 7.4 million people. It has involved more than 18,000 employees and community volunteers providing over 120,000 volunteer hours. It has cost more than \$8.8m so far and used up almost 38,000 gallons

Several projects have been completed by the Birstall staff including enhancing the Hollybank Trust residential home for people with profound disabilities in Mirfield, renovating playground equipment at Mirfield Memorial Recreation Garden and transforming a neglected courtyard

at Fairfield School in Batley for pupils with complex needs into a peaceful sensory garden.
Probably the biggest project saw 100 PPG volunteers transform Batley Railway Station. The shop and café, as well as the front of the building, were painted by the volunteers while a mural depicting iconic venues in the town - including the famous Frontier club and Batley Bulldogs' Mount Pleasant ground - was created in the subway.

Another project saw 38 PPG volunteers and nine community volunteers refurbish Birstall Community Centre, putting in a new commercial kitchen and bathroom, modernising the windows and ceiling and giving the walls plenty of vibrant colour.

The colours there are especially suitable for people with visual impairments, the elderly and people suffering from dementia by painting walls, doors, frames and handrails in contrasting colours.



4. ISAAC TIMMINS LTD

e all know this company as the Myers Group but why is the parent company called Isaac Timmins Ltd?

And what link does Myers have to some of Huddersfield's greatest landmarks?

Well, it was originally founded as Isaac Timmins Ltd in 1929 when Hervey Myers bought housebuilding company Isaac Timmins and the Myers Group can trace its modernday heritage back to 1959 when the Readymix Huddersfield concrete business was incorporated. The Readymix operation has since expanded into a regional business with four strategically located manufacturing plants.

Its concrete was used to build Emley Moor mast in 1969 and also the M62 motorway and the landmark Scammonden Dam bridge. Group companies also include Johnsons Wellfield quarries founded in 1854 and acquired by the Myers family in 1979. Johnsons Wellfield is Britain's leading supplier of natural hard Yorkstone and the only division in the group that sells nationwide. Its stone features on the imposing Creative Arts School at the University of Huddersfield.

Myers Building Supplies is a builders' merchant with 15 branches throughout Yorkshire. There are also two Huddersfield focused specialist businesses – Myers Timber and Myers Skip Hire – and it also has a specialist kitchen department.

The Myers Group is now into its fourth generation run by codirectors, brother and sister James

and Katie Berry, and employs 350 people across West Yorkshire. It invested more than £1m into its Huddersfield headquarters on Barr Street at Bradley Mills in 2020 and other branches have recently been renovated including Denby Dale and Penistone.

Myers supports several charities including Kirkwood Hospice and the Yorkshire Air Ambulance.

5. PCSPECIALIST LTD

ust 19 years ago a
Huddersfield A-level student
started this business in his
back bedroom - and in 2021 its
profits were £3.6m, almost double
the 2020 figure.

The company only operates online and specialises in top quality computers for businesses and gaming enthusiasts and is now delivering a computer somewhere in Europe every 5 minutes - that's more than 100,000 a year. It was started in 2003 by Danny Williams at his home in Lepton and he now modestly describes himself as Tea Room Manager at his hugely successful business based at Grange Moor which employs well over 200 people.

Danny was 17 at the time he began his business, studying at Greenhead College and was due to go to the University of Leeds to study a business degree but realised his own idea may be a goer when he built and sold four computers a week so carried on with it instead. Apart from selling direct, the

company's products are also sold through huge names such as Currys PC World and Very.

Danny, a former King James' School pupil, said: "I grew up in Lepton

and my bedroom floor was covered in computer bits - so much so my bed was tipped on its end most of the time - and the spare bedroom was my stockroom."

He moved to tiny business premises in Shepley and took on five staff but over the years

the business has kept growing and growing - never more so than during the pandemic - and is now in two units covering around 50,000 sq ft.

Danny, 37, said: "It's been an absolute whirlwind. We were doing OK but the pandemic has totally changed people's working patterns and with people also stuck at home during the lockdowns it all meant there was a huge demand for the kind of computers we can

provide. Everything we do is built at Grange Moor and then sent out to customers in the UK and across Europe."

Industrial Estate at Waterloo in Huddersfield where it still has its head office. It now also has offices worldwide including Europe, the USA, Australia, Japan, Korea, China, India and Russia.

The business has worked with some of the biggest brand names in the world including BMW, Rolls Royce, Bentley, Tesla, Ferrari, Jaguar Land Rover, Amazon, Harrods, Estée Lauder, John Lewis, Waitrose, HSBC, Barclays, Lloyds Banking Group, Specsavers, Sky, Wembley Stadium, Virgin Atlantic, Arsenal Football Club, Hard Rock Café and

If the worst happens they all turn to FMG for help and its staff will organise removing the damaged vehicles, sorting out a replacement and dealing with all the administration and hassle these incidents cause right through to the damaged vehicle being returned fully repaired. FMG now manages half-a-million vehicles and attends an incident every three minutes.

FMG is the leading company in the UK providing such a complex and comprehensive service.

The Highways Agency (now Highways England) has relied on FMG since 2008 to manage all the vehicle recovery incidents it deals with on 4,300 miles of motorways and significant A-roads. ummins employs hundreds of people at its base on St Andrews Road, Huddersfield, where it manufactures medium to heavy-duty diesel engine turbos. The story began in March 1952 as Holset Engineering Co Ltd founded by business partners Brian Holmes and Paul Croset - hence the name Holset which combines their surnames - and began manufacturing turbochargers

in the town in 1958 before it was bought by Cummins in 1973. Around 40% of the world's lorries are powered by a Holset-branded turbocharger including major names such as Volvo, Scania, DAF, MAN and Ford.

Cummins also designs and manufactures turbochargers for buses, trains and ships.

ADARE SEC LTD

dare SEC helps businesses to communicate with its customers as effectively as possible using everything from print to emails and text messages.

This can be quite a complex task when large companies have to deal



with different customers in different ways with some wanting communications by letter while others are happy to receive emails and texts. Adare SEC are also experts at helping businesses to communicate with people who are vulnerable or have special needs such as sight loss.

Lawton's supplies woollen yarns to all major carpeting manufacturers in the UK and exports to Europe, Asia, and America. Without Lawton, the UK market would be reliant on international imports.

The company is in private ownership following a £13.4m management buy-out earlier this summer.

It's also a major manufacturer of pet foods with a factory in Birstall and big brand dog and cat food names Mars produces include Whiskas, Pedigree, lams, Sheba and Cesar.

The confectionary brands also include Snickers, Twix, Galaxy and Maltesers along with Orbit chewing gum. Foods include Dolmio pasta sauces and Uncle Ben's rice which has recently changed its name to Ben's Original. Mars was founded in 1911 when Frank Mars made the first sweets in the kitchen at his home in Washington,

USA. It now employs 130,000 people at 454 sites in 80 countries.

This Mirfield-based family company was set up in 1916 and now has a

The group also includes the Slumberdown and Snuggledown brands along with John Cotton Europe which recently opened a new factory in Poland, providing 100 new jobs. In 2017 John Cotton bought Australia's leading pillow and duvet producing business, Tontine, which has an annual turnover of £25m, employs 90 people and is located near Melbourne.

The company is led by chairman John Cotton who took over from his father in 1965.

FOX'S BISCUITS

he company's roots can be traced back to 1853 when Michael Spedding baked his first batch of brandy snaps and sold them to shops, traders and shows from his Batley bakery. When his son-in-law, Fred Ellis Fox, took over in 1897 he renamed it F E Fox & Co.

The Batley factory now bakes 6 million biscuits a year that are munched worldwide. Some of the UK's most loved Fox's biscuits including crunch creams, crinkle crunch, Viennese and party rings for kids. For special occasions such as Christmas, Fox's do an indulgent chocolate selection tin simply called

Fabulously. The Fox's website features lots of recipes you can bake using their biscuits.

Fox's is now owned by the Wakefieldbased 2 Sisters Food Group which also owns Holland's, a Lancashire baker famous for its pies.



RUDDI'S RETREAT

Many families with disabled children would never have the chance to go on holiday if it wasn't for a Huddersfield charity that now wants to do even more.

Ruddi's Retreat was set up 10 years ago and provides free caravan breaks for families with disabled children but its four caravans are not enough to meet the ever-increasing need so this summer launched a new appeal to raise £50,000 to buy a fifth caravan. The four are now on a site near Filev on the Yorkshire coast and the hope is to buy another one on the west coast, probably near Blackpool.

It would be great if businesses

throughout Kirklees would adopt Ruddi's Retreat as their chosen charity for the year.

Other money comes from fundraising, applications for grants such as the National Lottery and Ruddi's shop and café in Slaithwaite that specialises in cakes, afternoon teas, lunches and sweets.

Most people have heard of the Yorkshire Children's Centre in Huddersfield ... but few probably know exactly what it does.

Well, the charity has its roots back to 1974 when it was set up by visionary educationalist Brian Jackson and has been helping families ever since. It now focuses on four



wellbeing, employability and healthy relationships.

But the services are costly to run at £3m a year and the charity wants businesses to get involved so they can provide their much-needed support for more people.

Brian Jackson colleges in Huddersfield and Heckmondwike provide education for up to 80 young people aged 13-16 who have social, emotional and mental health difficulties and have been permanently excluded or are at risk of exclusion from mainstream schools. The charity also works with some of the most disadvantaged people in Kirklees to try to get them into

The YCC promotes healthy relationships at its child contact centres, supporting parents, grandparents or other family members who are no longer living with their children or there has been a breakdown in family relationships. As part of a scheme called

training or work.

Thriving Kirklees involving several organisations, the YCC provides a range of services including Safety in the Home and Safety Rangers for school children. It also offers health, nutrition and wellbeing support to families in need.

BANK

This is one of the largest food banks in North Kirklees and is facing a tough time at the moment with demand on its services going up but donations are falling.

Fusion supported 558 people in August, a 59% increase from August 2021, and provided food for 218 children and young people, an increase of 86%. During the month, Fusion provided 12,192 meals, 340 food parcels, 156 toiletry packs and 104 cleaning packs.

Fusion Food Bank director Tasha Dyson said: "Recently we have seen a decline in donations which is a worrying time as demand for our service is continuing to increase significantly and we are concerned this will be ongoing due to the current cost of living crisis we're facing. "We know that testing and uncertain times will continue and our plan for this is to continue to support those who need our help and to work at receiving donations to ensure we remain well stocked."

People can donate food items or give Fusion money either in cash, cheque or by bank transfer. It has set

FORGET ME NOT CHILDREN'S HOSPICE

The hospice supports children with life-shortening conditions and their families across West Yorkshire.

Forget Me Not helps families make the most of every moment they have together by providing superb nursing care, respite, hydrotherapy, creative therapy, days out, memory making, end of life care, bereavement support and counselling.



It is led by a highly specialist team of nurses and therapists providing services that are rated 'outstanding' by the Care Quality Commission and everything Forget Me Not does is free for families.

At the heart of its services is Russell House, a state-of-the-art children's hospice in Huddersfield which opened 10 years ago and features a hydrotherapy pool, creative therapy kit and a sensory room. Forget Me Not also takes its services to families in their own homes.

The charity is always looking for new ways to help families in need. It was the first children's hospice in Europe to employ a midwife to support families facing the loss of their baby

during pregnancy and birth. But with just a small proportion of the £4m the hospice needs each year coming from the government or NHS, Forget Me Not relies on charitable donations, support from businesses, people volunteering their time, shopping in the charity's shops or leaving a gift in their will to fund its vital work.

Forget Me Not's chief executive Luen Thompson said: "We've supported more than 800 families since our hospice was built but we wouldn't be here at all without the whole community helping us to raise the funds."

orkshireLive is fast approaching its third anniversary and the team continue to cement their place as the most read regional news website in the region.

That is some feat when you consider we have gone head to head with one of the most established and traditional news brands in the country.

But it was never about locking horns with the competition, instead we saw the opportunity to add to the news offering in the biggest and best

And that we have done. Our team - which is spread across Huddersfield, Leeds and West
