Welcome to the fifth edition of the **Kirklees Top 100 Companies, showcasing the top companies from across the district that have demonstrated exceptional performance and resilience.**

We're delighted that the Top 100 has reached the key milestone of its fifth birthday and this year's edition includes some special features to celebrate this achievement, including a new award for the most consistent business performance over this period and a retrospective article by Emeritus Professor Jill Johnes, Huddersfield Business School.

The Top 100 initiative goes from strength to strength. Building on existing activities including our Talent group, dedicated Careers Edition of the brochure (now in its third year) and regular social media, new developments this year include launching a new podcast series featuring interviews with inspirational Kirklees business leaders - you can find these by visiting Businesskirklees.com and searching for "Top 100 Podcasts". Many thanks to local production company Giant Leap Productions for bringing this to life.

We also partnered with local charity Fresh Futures, who do amazing work supporting vulnerable and disadvantaged young people and families, to host our summer networking event.

The Top 100 list is produced by Huddersfield Business School using published accounts data from the FAME BVD database and based on five criteria related to financial performance, as explained in the methodology article on page 4.

As in previous years there have been some interesting moves up and down the rankings and 12 businesses featuring in the Top 100 for the first time. One business features in the top 10 for the first time. From a sectoral perspective, just over half (51) of the Top 100 companies are in the

manufacturing or engineering sectors and 26 are in wholesale or retail.



The Kirklees Top 100 2024/25

HOW THE LIST WAS COMPILED

Background

As in all previous editions of this listing, the Kirklees Top 100 was compiled this year using as its source the FAME BVD database which contains a variety of information on more than 11 million companies in the UK and Ireland. The information includes financial data, information on directors, and company structure including shareholders, subsidiaries and branches, and industry descriptions and SIC codes; much of the data derives from accounts and documents filed at Companies House (in the UK). The FAME BVD database is the only source used to derive the metrics in the listing.

Strict parameters were used to derive the set of companies from which the Top 100 were ultimately drawn. In terms of geographical location, we selected from the FAME BVD database all active companies with a registered office address within the Kirklees region defined as having a postcode in Kirklees (as per the NUTS 3 level region definition). The relevant data was downloaded on July 1st, 2024; any data available in the FAME BVD database after this date was not included in this edition of the Top 100 list. To ensure a Kirklees focus, any company whose website presents as its only contact an address outside of Kirklees was removed even though their registered office was recorded in FAME as in Kirklees. This affected only a very small number of companies.

Methodology

The Kirklees Top 100 ranking is derived from the following indicators: staff head count (i.e. number of employees); turnover; growth in turnover between the latest and previous years accounts; profit before tax; and shareholders' funds. Each of these

indicators is ranked (best- to lowest-performing), and then these rankings are summed. The final position is determined by ranking the sum of ranks. Thus, each of the five metrics carries equal weight in determining the final ranking. This is the same methodological approach as in our previous four editions.

The period over which the ranking applies is determined by the latest information held in FAME BVD and filed by each company in the Kirklees list. Where we identified subsidiaries and sister companies, we applied a consistent approach to ensure that the highest or largest company (in terms of revenue) in the hierarchy was retained, so long (of course) as the registered office was in the defined Kirklees area. Companies deemed to be charities or in the education sector (all levels), or with turnover less than £1000 or with non-numeric data were removed from the data set. No businesses were offered the option of being included (or not).

Economic context

Companies continue to face external challenges. While the restrictions of the Covid-19 pandemic are a thing of the past, the lingering impact of the pandemic, as well as Brexit, continue to challenge businesses.

More recently there are new challenges: the wars in Ukraine and the Middle East, the ongoing impacts on supply chains and commodities, and inflationary pressures which have led to interest rates at a 15-year high as at the data download date. In terms of this list, it should be remembered that each company's data is a specific snapshot (indicated by the date in the "Latest Account Date" column) and so the extent of the impact of precise external factors on businesses in this list varies by company.

Kirklees Context

As always, the Kirklees Top 100 showcases the variety of businesses thriving in our area, and as expected, the type of businesses doing well varies with the changing economic environment.

This year, five of our Top 10 companies are in the manufacturing sector (with a couple of those in the medicinal and botanical area). Alongside these manufacturing companies we have businesses working in transportation and construction. The variety of sectors broadens as we go down the list and Kirklees continues to have a vibrant and diverse business economy from a wide range of sectors.

Limitations

This list does not claim to indicate each business's economic importance to the Kirklees geographical area.

It is based on five specific metrics which are deemed to be indicators of success. All metrics contribute equally to the final ranking. The list is a means of showcasing and celebrating business activity in the Kirklees region. Unfortunately, not all companies' complete set of data are included in FAME BVD, and so businesses which might expect to be in the list are not for that reason. Kirklees also hosts important businesses which do not have a registered primary address in the region, yet their contributions to the Kirklees region may well be substantial. These businesses, along with major public sector organisations, are showcased separately in this publication and are not in any ranked order.

FIVE YEARS OF KIRKLEES TOP 100

Background

As we launch the 5th edition of the Kirklees Top 100 it seems like a good time to reflect on what we have learned about the Kirklees business environment over the five lists and what we'd like to achieve in the future. The partners first got together in late 2019 to consider the possibility of producing a Kirklees Top 100 list of companies, when we articulated our aims and objectives:

- To strengthen bonds between the Kirklees business community.
- To raise the profile of Kirklees businesses and the district as an attractive destination for inward investment, business start-up, scale-up and growth.
- To instil prestige for members of the Kirklees Top 100 Companies and offer the benefits of exclusive networking and relationships between members.
- To better co-ordinate the efforts of the major anchor institutions in developing 'key account' relationships with the Top 100 Companies and ensuring they are well connected into dialogue about the future of the Kirklees economy.
- To broker stronger relationships between the Top 100 Companies and founding partners to increase the take up of local talent; education and skills initiatives; innovation and business support; and other appropriate initiatives.
- To encourage stronger engagement between smaller firms and those larger

organisations on the Kirklees Top 100 Companies list to encourage greater collaboration, sharing expertise and business opportunities.

Having agreed on the objectives and the methodology which would be used to compute the list, we were faced with the pandemic and accompanying lockdown. We questioned whether 2020 was the time to launch the Kirklees Top 100 and quickly agreed that with the challenges facing businesses at that time and the gloomy economic outlook, it was actually the perfect time to celebrate business achievements and resilience, and to provide support and networking opportunities for our local businesses.

The on-going challenges of the pandemic meant that our first two launch events were virtual, and it wasn't until summer of 2022 that we had our first face-to-face networking event, with the launch of the third edition at the John Smith's Stadium in October 2022 being our first in-person launch event.

As the momentum of and interest in the Kirklees Top 100 activities grew, we introduced an annual Careers Edition in autumn of 2020 to raise awareness amongst students in schools and the university of opportunities in local companies, and we launched a special SMEs edition in summer of 2023, thereby initiating links between the top-performing larger companies in the region and the fast-growing SMEs - all part of our initiative objectives.

As we launch our fifth edition it's worth taking a step back and looking a bit more closely at the companies and performance across the Kirklees Top 100 listings.

Consistent performance

Over the five editions around 170 different Kirklees companies have appeared in the listings, and just under one quarter of these have been in every single one of the five listings. We might describe these as the companies in Kirklees which have been showing extraordinary resilience in challenging times and performing consistently well over the five listings.

If we focus on the 39 companies which have appeared in all five Kirklees Top 100 listings, we can see that the vast majority of these are in the manufacturing sector. Kirklees' manufacturing history therefore appears to continue to dominate today's successful business environment.



In addition, a substantial proportion of the consistent performers are businesses involved in the management

of companies and enterprises, and those involved in wholesale trade - see figure above.

The top ten of these companies and their average ranking over the period are displayed in the table above. The performance of these top 10 companies is truly exceptional - the top two are in the top 10 on average across all five years of the listing demonstrating consistently outstanding performance across economically challenging times.

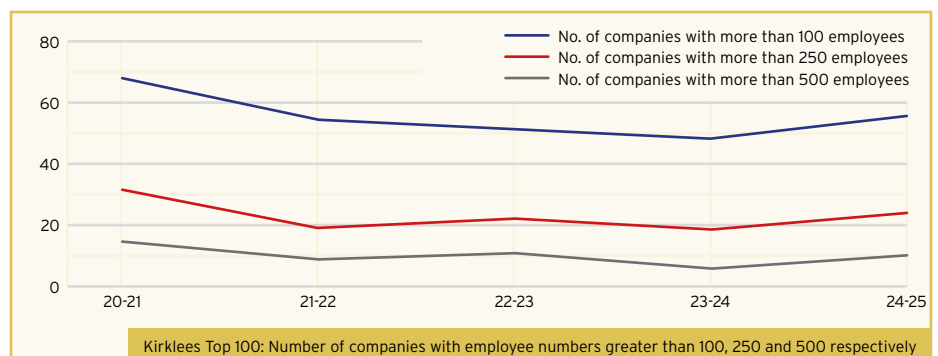
Size of Kirklees Top 100 Companies

Kirklees Top 100 companies are not, as a group particularly large, with an average number of employees of between 200 and 330 - it's interesting to note that the average was generally falling for the first four listing editions but has seen a small rise in the latest year.

It's difficult to read too much into such a small number of observations but it's tempting to suggest that the pandemic and subsequent economic hits to business had a detrimental effect on employment and we might now be seeing a bounce back, but we will be able to see more as we produce

subsequent editions of the Kirklees Top 100. This pattern is broadly mirrored by the median number of employees, values of which are considerably lower than the average suggesting that, as you might expect, there is a long tail of smaller companies in the list.

Nevertheless, as the figure below shows, while the majority of companies are largely below 250 employees (falling into the SME size range based on employee numbers), Kirklees is host to a number of large companies. On average across the five editions, 10 companies in the list exceed 500 employees.



5TH ANNIVERSARY SPECIAL AWARD – MOST CONSISTENT PERFORMANCE

PPG ARCHITECTURAL COATINGS UK LIMITED

The 5th Anniversary Special Award for the most consistent performance is awarded to PPG Architectural Coatings UK Limited. Over the last 5 years PPG had the highest average position.

For more than 140 years, PPG has been at the forefront of developing and delivering paints, coatings, and specialty materials. With a commitment to innovation and excellence, PPG collaborates closely with clients to address their most pressing challenges. Headquartered in Pittsburgh, USA, PPG operates in more than 70 countries and reported net sales of \$18.2 billion in 2023.

The PPG plant in North Kirklees is its largest paint manufacturing complex in Europe. Since 1983, PPG, the renowned maker of the Johnstone's and Leyland

paint brands, has operated from its expansive 65-acre site in Birstall. Employing over 1,500 people across the UK and Ireland, PPG has a significant presence in the region.

PPG's strong commitment to social responsibility is exemplified by its Colourful Communities programme, which encourages employees to volunteer their

time and utilise PPG products to enhance their local communities.

In 2023, PPG Architectural Coatings UK began a partnership with STEM Learning UK, pledging funding to support both local schools around Birstall, and 58 teachers across the UK, in continuing professional development (CPD) courses offered by STEM Learning.



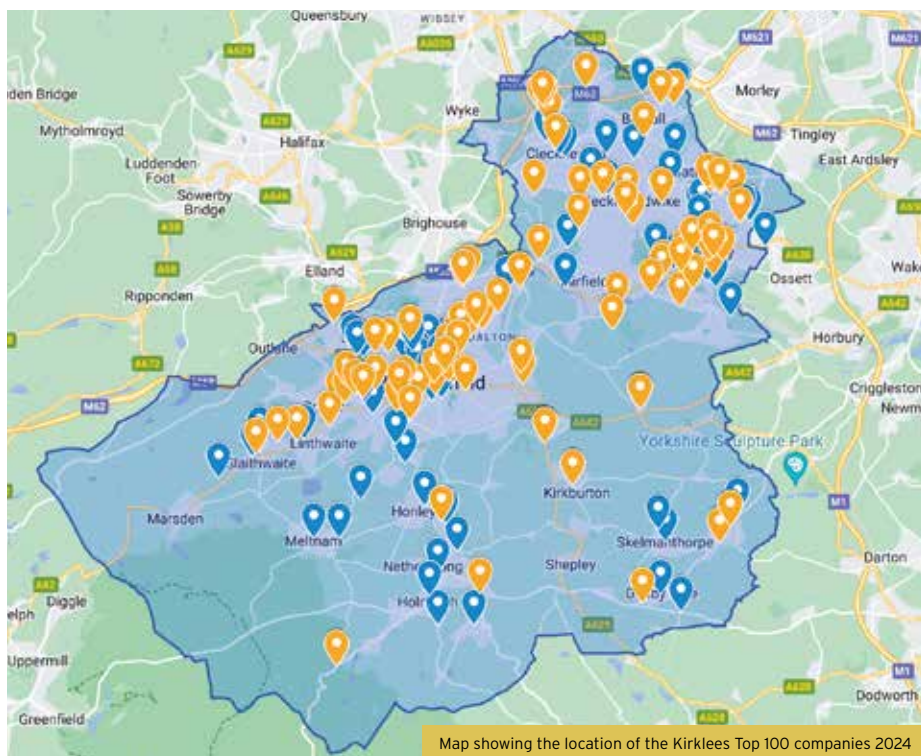

Geographical location

The map to the right, with the Kirklees region outlined in dark blue and shaded in light blue, permits scrutiny of the location of the Top 100 companies - the orange markers show the companies in the latest edition, but it is reflective of earlier editions too.

Clearly many of our Top 100 companies are located in and around Huddersfield, and on the fringes of other urban areas such as Leeds and Wakefield. But what is particularly noticeable is that many of our Top 100 are located close to the A62 and M62 suggesting good road connections are important for these successful companies.

The more rural areas in the south of the Kirklees region are much less populated with Kirklees Top 100 companies, and this makes an interesting contrast with the Kirklees Top 100 *Focus on SMEs* listing produced in 2023 where we found more of a spread across the region (see blue markers).



Kirklees Top 100 networks, networking and social media

Since the launch of the first Kirklees Top 100 listing in October 2020 up until summer of 2024, there have been 10 official networking events attracting over 550 registered attendees.

The events include four main edition launches, three Careers Edition launches and three summer networking sessions. In addition, the partners have overseen and supported some specialist networks. The Talent Group has been meeting since 2021,

has had eight events with 102 registered attendees, and has explored themes such as graduate development, recruitment and retention, hybrid working, and the cost of living crisis. These meetings have been held online and in-person at different organisations across Kirklees including STADA (Thornton & Ross) in Slaithwaite and UK Greetings in Dewsbury. The Environmental Group, led by Kirklees Council, has already met twice with another meeting planned for November.

Through the publication of the first five editions of the company listing, the Kirklees Top 100 has successfully showcased the excellence, diversity and resilience in the Kirklees business environment. We, the partners, are very much committed to continuing to showcase and support businesses and their success in future editions of the Kirklees Top 100.

LOOKING TO THE FUTURE: Kirklees £2bn investment

Driven by an ambitious vision for the future, Kirklees is witnessing significant investment, with a range of high profile and impactful projects across the district already underway or at an advanced stage of development.

Sustainable, long-term, inclusive growth in Huddersfield, Dewsbury, Batley, Cleckheaton, Heckmondwike, Holmfirth and Marsden is being fuelled by a comprehensive approach to regeneration, strong leadership from both the public and private sectors, responsible investment, and thriving high-growth businesses.

Our rich culture, scenic landscapes and strategic location provide a high quality of life, attracting investors and residents alike - with the best yet to come.

A series of community-led masterplans or Blueprints are catalysing the regeneration of town centres, enhancing connectivity and delivering improved public realm, infrastructure, culture and business growth through targeted investments that will see more than £2bn of planned private and public infrastructure investment over the next ten years.

CONNECTIVITY IS KEY

Making us one of the best-connected places in the North of England, modernisation of Kirklees' public transport system is taking place at pace.

Kirklees lies at the very heart of the Transpennine Route Upgrade (TRU) - the largest infrastructure investment programme currently being undertaken in the UK. This multi-billion pound railway improvement programme will double network capacity, substantially enhance Huddersfield, Dewsbury, Marsden, Slaithwaite, Mirfield and Ravensthorpe stations at pivotal locations along the route, and reduce journey times to Leeds, York, and Manchester.

Alongside TRU, the West Yorkshire Combined Authority is investing over £42m to revitalise bus stations in Dewsbury, Heckmondwike and Huddersfield. This will boost usage, improve connectivity between



our bus and rail networks and ensure Kirklees is well placed to benefit from future plans to bring bus services under public control.

Kirklees is also part of the Combined Authority's plans for Mass Transit, with proposals to connect Leeds and Dewsbury in the future.

OVER £1BN INVESTMENT IN HUDDERSFIELD TOWN CENTRE

Huddersfield is witnessing a significant transformation, with a range of high profile and impactful projects underway, breathing

new life into historic buildings and future-proofing Huddersfield as a great place to live, work and invest. Phase 1 of the £250m Our Cultural Heart development is underway, creating a dynamic new cultural hub. Public realm improvements across the Town are breathing new life into the retail quarter, plus the ongoing £9.2m redevelopment of Kingsgate shopping centre will further enhance the towns leisure offer, providing a new six screen cinema, bowling and leisure complex.

The iconic George Hotel is undergoing restoration to become a brand new Radisson RED and the Town's historic Victorian market is set for a £16m restoration breathing new life into the Grade 2 listed building and creating a new hub for start-ups.

Beyond the Blueprint, there are ambitious plans for the Station to Stadium Enterprise Corridor, a long-term strategic investment corridor connecting Huddersfield's Railway Station to the John Smith's Stadium. It's home to the West Yorkshire Healthtech and Digital Tech Investment Zone that will accelerate innovation, jobs and growth in the health and life science sectors, underpinned by the University of Huddersfield's £250 million National Health Innovation Campus development, creating the largest, most dynamic centre for healthcare innovation and workforce development in the North of England.





Dewsbury Creative Town Arts Programme, Emmeline North

ALL CHANGE FOR DEWSBURY

Dewsbury is a leading force in the bed and furniture manufacturing industries. This multicultural town is known for its affordable commercial property and its excellent location, close to Leeds and key road networks. It's in a key location to take advantage of the proposed West Yorkshire Mass Transit scheme.

The Dewsbury Blueprint highlights significant opportunities to transform the town through investments in residential and office schemes, rejuvenating the public realm, retail and business space. Key projects supported by the Government's Towns Fund programme include the revitalisation of Dewsbury Arcade (now on-site) and Dewsbury Market with the potential to transform the town centre.

Complementing the regeneration of Dewsbury Town Centre, major development sites at Chidswell and Dewsbury Riverside will deliver circa 5000 homes and over 1.5 million ft² of employment land over the next decade, benefitting from their proximity to the TRU and proposed Mass Transit schemes.

DRIVING HEALTH INNOVATION

Huddersfield is becoming a significant hub for health innovation in the UK, driven by efforts to improve health outcomes and productivity across the region. At the heart of this is the University of Huddersfield's National Health Innovation Campus (NHIC) that aims to reshape the healthcare landscape.

With its first building opening in September 2024, the National Health Innovation Campus (NHIC) aims to create a world-class hub for healthcare innovation where researchers, clinicians and industry partners work together to tackle some of the most pressing health challenges locally, nationally and internationally.

Named after the first black NHS matron, the Daphne Steele Building will be the first on campus, housing a Health and Wellbeing Academy and world-leading research facilities. It will also offer public services, including telehealth, podiatry, sports and physiotherapy clinics and a mock-up residential home.

Specialist clinical and allied health professional teaching spaces will equip students and practitioners with the skills and knowledge necessary to thrive in a rapidly evolving healthcare environment. This focus on education and workforce development is essential for ensuring that the healthcare workforce is prepared to meet future challenges.

The NHIC is strategically located within the 'Station to Stadium' enterprise and innovation corridor in Huddersfield, a focal point for the West Yorkshire Healthtech and Digital Tech Investment Zone, announced earlier this year by the UK government. This location positions the NHIC as a key player in the wider region's economic regeneration efforts, addressing both local health disparities and the £8.5 billion job productivity gap between West Yorkshire and the UK average.

Complementing the NHIC is the Huddersfield Health Innovation Partnership (HHIP), a dynamic collaboration between the University of Huddersfield, 3M Buckley Innovation Centre (3M BIC), Business Kirklees, Mid Yorkshire Teaching NHS Trust, Calderdale and Huddersfield NHS Foundation Trust and other local and regional health and wellbeing partners, including Health Innovation Yorkshire & Humber.

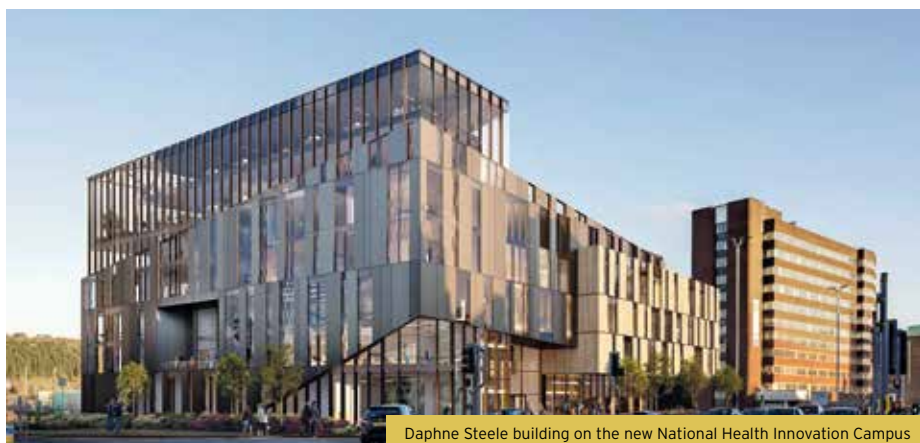
It fosters partnerships between academia, industry, healthcare providers and the third sector to accelerate innovation into real-world health solutions. Businesses get access to technology, mentoring, grants, expert knowledge and collaborative opportunities with the NHS and academia, to develop innovative products and services in health and wellbeing. This project is part-funded by the UK Government through the UK Shared Prosperity Fund.

The University is building a new Health and Wellbeing Innovation Centre, based on the same model as the 3M BIC but focused on health-related companies, on the top floor of the second building on the new campus. It will become an incubator aimed at local entrepreneurs and growing companies in establishing health and wellbeing innovations, with offices, labs, co-working and event space available, as well as a Maker Space to support product development. The ground floor will host

a Community Diagnostic Centre Hub (CDC), in partnership with Calderdale and Huddersfield NHS Foundation Trust.

And this is just the start. With plans to develop seven buildings on the campus site over the next decade, as well as complementary initiatives such as Business Kirklees' Thrive and those from across the wider Leeds City Region to drive health and wellbeing innovation, this regional collaborative effort will make significant improvements in both health outcomes and productivity and will transform the future of healthcare.

DIGITAL TRANSIT

Improving transportation through digitisation and automation

Since it was founded in 2018, Digital Transit has quickly established itself as a leader in digital transformation and technology solutions.

Based at the 3M Buckley Innovation Centre, it offers state-of-the-art capabilities in machine vision, condition monitoring, cybersecurity and safety-critical software, with a primary focus on the railway sector, delivering tailored solutions that enhance efficiency, security and scalability.

Through strategic collaborations, the company has secured over £1m in funding,

including Eureka Eurostars for developing advanced sensing technologies to improve the safety and efficiency of rail overhead lines.

The company has also received Innovate UK funding to create an AI-powered cybersecurity system and to advance its Digital Twin Energy Grid project.

In 2023, the company won a Cybersecurity Innovate UK competition, embarking on a three-year project in collaboration with the Institute of Railway Research (IRR) at the University of Huddersfield and Heron Technology in Singapore to strengthen cybersecurity resilience in the rail industry.

The company has also received funding through Innovate UK's Invest-ability training in 2022, to improve business planning, market research and secure IP audits, as well as securing two Innovate UK Smart awards.

In 2024, it joined the Advanced Machinery & Productivity Initiative (AMPI) to further develop its innovative electrochemical polishing technology and has been given the green light for a funding project worth £1.2million over the next two years.

Based in Holmfirth, HR Blowers is committed to innovation and technology and has worked with the University of Huddersfield on two Knowledge Transfer Partnerships to enhance blower performance, efficiency and bulk solid handling.

The company recently expanded, relocating its engineering and design facility to a purpose-built facility and establishing a test house for analysing blower performance and material conveying characteristics.



KIRKLEES INNOVATION VOUCHER SCHEME



This year's Top 100 initiative presents a timely opportunity to reflect on the success of the Kirklees Innovation Voucher scheme, which ended in March 2024. Funded by West Yorkshire Combined Authority and Kirklees Council, the Innovation Voucher programme was designed to plug a gap in the support system and assist SMEs with grant support for small scale or early-stage innovation activity. The scheme supported the development of new and innovative products or processes - businesses could apply for funding for projects up to £10,000 with the Council funding 50% of the activity up to a maximum of £5,000.

The programme had a target of providing 37 grants to businesses during the lifetime of the initiative but exceeded this, awarding 42 Kirklees Innovation Vouchers to SMEs worth over £176,000. A further £206,000 was leveraged in private investment. Projects supported ranged from tailored or bespoke digital transformation activities such as ERP (Enterprise Resource Planning) systems that greatly improved productivity and the use of AI within the businesses, to brand new product designs, ranging from protective equipment for construction workers to products designed to prevent flooding in the household.

The programme was evaluated externally and all beneficiaries that responded spoke positively of the voucher programme. The programme enabled businesses to develop projects that they wouldn't have completed without the help of the scheme due to funding and time constraints and allowed the Council to build relationships with local SMEs.

Although the local Innovation Voucher programme has now ended, learning from the Kirklees programme has informed the design of the West Yorkshire Combined Authority's Ignite innovation voucher, which offers businesses looking for innovation support for the first time. Ignite vouchers are worth up to £5,000 and will provide 50% of the funding for innovation projects.

CUMMINS TURBO TECHNOLOGIES

Cummins employs just over 1,000 people at its base on St Andrews Road, Huddersfield, where it manufactures medium to heavy-duty diesel engine turbos.

The story began in March 1952 as Holset Engineering Co Ltd founded by business partners Brian Holmes and Paul Croset -



hence the name Holset which combines their surnames. The business began manufacturing turbochargers in the town in 1958 before it was bought by Cummins in 1973.

Around 40% of the world's lorries are powered by a Holset-branded turbocharger including major names such as Volvo, Scania, DAF, MAN and Ford. Cummins also designs and manufactures turbochargers for buses, trains and ships along with investing in future technologies to make it a greener and more sustainable world in which we live and work in, protecting our planet for future generations.

The company is very community minded and provides volunteers for schemes such as a project to set up a Huddersfield Riverside Nature Park alongside the River Colne near to Huddersfield town centre.



ADARE SEC

Adare SEC helps businesses to communicate with customers as effectively as possible using everything from print to emails and text messages. The company also helps businesses to communicate with people who are vulnerable or have special needs such as sight loss.

Adare SEC was established in 2006 at Clayton West with its roots traced back to the former Waddington Business Forms that was based on the same site. It produces hundreds of millions of important customer communications every year ranging from PINS for credit cards and bank statements to welcome packs for new customers joining businesses ranging from banks to insurance companies.

INCORA (FORMERLY WESCO)

Aircraft consist of tens of thousands of parts but if something needs replacing where do you get it from? Well, Incora! - formed when two major aircraft parts companies Wesco Aircraft and Pattonair joined together in 2020 - have consolidated their Clayton West and Cleckheaton sites into a new one at Mirfield where they employ around 180 people.

It's a global company which stocks well over half-a-million components from more than 6,000 different suppliers

including engines, airframes, landing gear, electronics, bearings, sensors, chemicals and tools. The company has thousands of customers and its huge number of suppliers means customers only need to go to one place for parts rather than trying to source them from individual businesses. Wesco was founded in the USA in 1953 and expanded into Europe in 1988. Pattonair was founded in Weybridge, UK, in 1970.

Major customers include Boeing, Airbus, Rolls Royce, Pratt and Whitney, General Electric and GKN Aerospace.

MARS

Everyone knows about the famous Mars chocolate bars - but that's just a fraction of what this global company does. Mars is also a major manufacturer of pet foods and treats with a factory on Oakwell Way in Birstall where it solely focuses on treats for cats and dogs, such as dental sticks and chews.

Mars is a huge employer for the Kirklees area with well over 1,000 people working in Birstall round the clock on the production lines. The big brand dog and cat food names Mars produces include Whiskas, Pedigree, Iams, Sheba, Schmackos and Cesar. The confectionary brands also include Snickers, Twix, Galaxy and Maltesers along with Orbit chewing gum. Foods include Dolmio pasta sauces and Ben's Original rice.

Mars was founded in 1911 when Frank Mars made the first sweets in the kitchen at his home in Washington, USA. It now employs 130,000 people at 454 sites in 80 countries.

LV, specialising in insurance and finance, has had a call centre spread over two floors at the Folly Hall Mills complex in Huddersfield since 2010 and now employs around 380 people.

Formerly known as Liverpool Victoria with a history stretching back to 1843 when 'penny policies' were what the company was most commonly associated with – life insurance at its simplest. The insurance side now also includes home, car, travel and pet. In Huddersfield it specialises in motor insurance and Britannia Rescue vehicle breakdown cover.

As a mutual company it's owned by its policy holders, and has 1.25 million members. It works with a range of financial advisers and through them sells LV= products including life insurance, income protection, investments and retirement income solutions such as equity release and fixed term annuities.

LV= employs around 4,000 people nationwide and has more than 6.5 million customers.

KOBER LTD

In 2007 Forza Foods began supplying Asda with cooked meats from its first factory in Cleckheaton. In 2011, having outgrown this site, it opened a bigger cooked meats factory 12 miles away in Normanton and this became Forza's new home with the site in Cleckheaton turned into a bacon and gammon factory and became Kober.

Now Forza and Kober have grown into a best-in-class manufacturing operation, supplying Asda with products from ham slices to salami and from pizza toppings to party food. Asda-owned International Procurement and Logistics (IPL) bought Forza and Kober in 2016. IPL Chief Executive Nick Scrase said at the time: "Our one defining strategy that drives our business model is to simplify supply chains by cutting out the middle-man and then passing these cost savings onto Asda customers."

Forza and Kober employ almost 400 people in Cleckheaton and around 1,700 in West Yorkshire but is looking to expand its workforce due to ever-increasing demand for its products. They have recently launched a new joint website at www.forzakober.com

SYNGENTA

S yngenta is a world leading agriscience company and has been a major employer in Huddersfield, at its manufacturing premises on Leeds Road, for more than 100 years.

The site makes important crop protection products that help growers meet an ever increasing demand for food, feed and fuel. Economic research has shown that Syngenta operations contribute a staggering £140m GVA to the Kirklees economy each year, underpinning 1,000 skilled jobs. 75% of its workforce are

residents in Kirklees and the company is greatly involved in the local community, supporting more than 40 local community groups and charities in the last 12 months.

Syngenta Community and External Relations Manager, Carl Sykes said: "We continue to grow our site activities, investing in our apprenticeship programme, providing employment opportunities for local people and remain committed to keeping professional and skilled manufacturing jobs in Kirklees for many years to come."



FOX'S BURTON'S COMPANIES UK

Fox's Burton's Companies UK or FBC UK was formed when a Ferrero Related Company acquired two truly amazing biscuit manufacturer's Fox's and Burton's with heritage dating back to 1853 and 1895 respectively.

The merger of Fox's and Burton's as FBC UK has created the second largest branded biscuit baker in Britain. FBC UK make biscuits in several bakeries in England, Scotland and Wales and the company's Batley bakery can be traced back to 1853 when Michael Spedding baked his first

batch of brandy snaps and sold them to shops, traders and shows from his bakery. When his son-in-law, Fred Ellis Fox, took over in 1897 he renamed it F E Fox & Co.

The Batley factory now bakes billions of biscuits a year that are munched worldwide. THE STANDARD PATENT GLAZING COMPANY LIMITED

Founded in 1902, the Standard Patent Glazing Company has been manufacturing Patent Glazing systems, bars and ancillaries for over 100 years. The company has installed millions of square metres of Patent Glazing throughout the decades and examples of its finished work can be seen on many prestigious buildings including The Queen's Gallery in Buckingham Palace.

Based in Dewsbury, today the company offers five different Patent Glazing systems to suit all needs ranging from the very modern to its unique heritage system which is suitable for Grade 1 listed buildings.

J. & J.W. LONGBOTTOM LIMITED

APPRENTICESHIPS AT THE UNIVERSITY OF HUDDERSFIELD



Management and Leadership Apprenticeship Teaching Team

Enhance your Management and Leadership skills with an apprenticeship at the University of Huddersfield.

The University of Huddersfield's dynamic apprenticeship programmes are designed to propel individuals towards becoming better leaders and improving their management skills.

Meet Olivia Sykes, one of the learners on the Senior Leader Apprenticeship. In June 2024, Olivia won the University of Huddersfield's Level 7 Apprentice of the Year award. In this article, Olivia shares the direct impact the apprenticeship has had in her workplace and the invaluable lessons she's learnt.

Why did you decide to join our apprenticeship programme?

As a relatively new manager with just two years of experience, I was keen to get some official training to help me make well-informed decisions and enhance my skills. The apprenticeship offered everything I was looking for in terms of development.

How has the apprenticeship programme impacted your personal development?

I didn't realise the impact the apprenticeship would have, but it's fundamentally changed how I approach everything at work. It's given me the tools to approach anything - be it a change, initiative, problem, or a new project - allowing me to address it comprehensively and consider many different perspectives. Before the apprenticeship, I would rely on intuition, hoping I was making the right decisions. Now, I have a solid foundation to base my decisions on, giving me confidence that I'm doing the right thing.

What impact has your learning had on your current role?

The course content has been directly relevant to our workplace activities. For example, when we learnt about strategy, our organisation was in the midst of setting its strategy. So, after learning something,

I could go into work the next day and begin planning and implementing things.

In one of the sessions for the module 'Strategy and Innovation', we learnt about organisational culture, mission, and vision. In my organisation, we have a strong

mission and vision that's embedded in what we do. However, from the course, I recognised we could do more about organisational values as they are an important tool to guide employee's actions. In a volatile external environment, it's important for people to understand why they come to work every day. The week after the session, I put a proposal to our trustee board and our Chief Exec, and they said they couldn't believe they didn't think about this before! This led to a big staff training day where we discussed the values and gave employees the opportunity to make suggestions. Now, our finalised 6 values are embedded through our frameworks and everything we do. This initiative is the biggest impact that my learning has had in my role, and it all happened in three months!

This immediate application highlights the effectiveness of the apprenticeship approach, which might not be as achievable in a more traditional course format.

How are you finding the support from the tutors and services at the University of Huddersfield?

The apprenticeship team have been incredible from day one. There was a great level of attentiveness and familiarity right from the start of the application process. The tutors are not only knowledgeable but also personable, offering wrap-around support for both personal and course-related issues.

What has been your highlight so far?

The biggest highlight has been the learning on campus with peers from other organisations. I've previously done a management course that was completely online. Although this allowed me to develop a network, it didn't allow for building deeper connections and mutual support. I'm not only learning from the tutors, but also from fellow learners which is a massive bonus. The campus environment is fantastic for collaboration, providing an open and safe space that enhances the overall learning experience.

I couldn't recommend the programme more – it's absolutely brilliant. No matter your level, whether you're at a mid-manager level like me or in a senior role dealing with major strategic initiatives, everyone can gain valuable insights.

This is a very effective way to upskill your employees through supportive government funding and a practical, blended work-based approach to learning.
